_____ **RMFI camp meeting – I want to contribute to the general expenses of RMFI Camp meeting and workshop sessions June 18th thru June 21st.**

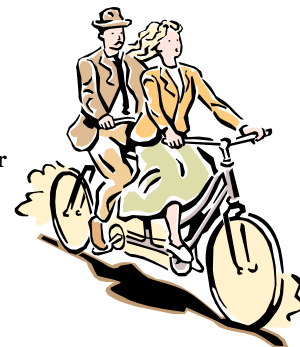
